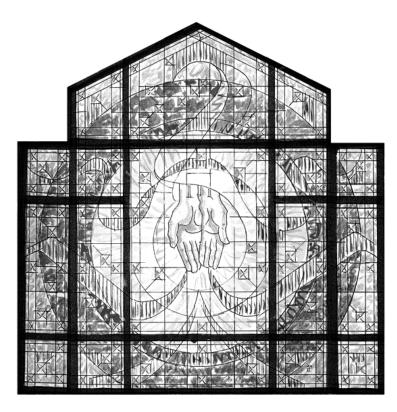

A motion was made to approve the constitutional change of treasurer/financial administrators. Seconded and adopted.

## 2018 ENDOWMENT COMMITTEE REPORT As of 12-31-2018

The main purpose of the Endowment Committee is to enhance the mission and outreach of Federated Church beyond the general obligation of the congregation. Another purpose of the committee is to encourage and promote gifts to the Endowment, and to invest, reinvest and administer the funds.

2018 committee members were; Rick Porter - Chairman and member-at-large, Gail Wurdeman - member-at-large and Governing Council Representative, John Hahn - member-at-large, and Pat Anderson - Property and Finance Committee representative. Terry Millard continues to be the investment advisor/agent for the invested funds.

There are four main categories of fund distributions from the Endowment, those being Christian Education, Community Service and Outreach, Wider Mission of Federated Church, and Capital Improvements. Additionally, the Governing Council may also approve fund distributions for other purposes. The Endowment Committee receives, reviews and recommends requests for funding, but the Governing Council approves all funds in and out of the Endowment.

#### 2018 ENDOWMENT COMMITTEE REPORT (cont.)

The committee had one meeting on October 2, 2018 but approved one recommendation to the Governing Council in the Spring of 2018 via email. As of 12-31-2018 the Endowment Fund balance was \$217,974.35. Below is a brief summary of the fund history:
